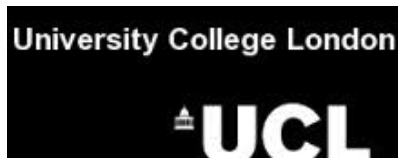

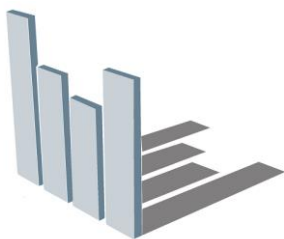

The Open Workshop Series in Business and Management Studies aims to promote top-quality academic and applied research in various fields of the social sciences. The main target audience includes doctoral students and more senior scholars interested in recent developments in conceptual frameworks as well as methodologies to address entrepreneurship and management challenges, providing a platform for sharing knowledge and networking with the local and international community. Some of the seminars are devoted to sustainability issues, broadly defined. Arnis Sauka is responsible for organising the Open Workshops at SSE Riga. Open Workshops are run since February 2014 and also offered to PhD students as a PhD level course, 'Contemporary Entrepreneurship Research'. On average, 25 participants attend the course, mostly PhD students from various universities in Latvia, including the University of Latvia, Riga Technical University, BA School of Business and Finance, and RISEBA University, Vidzeme University of Applied Sciences, Ventspils University of Applied Sciences. Also, more senior academics as well as practitioners attend the workshops. Workshops are moderated by Arnis Sauka. They are free of charge for participants and run in English.

#### ***Conference on Entrepreneurship, Innovativeness and Regional Development (2013-2107)***

This conference was first run in July 2013, aiming to bring together leading researchers from the universities and business schools in Latvia, Lithuania and Estonia, and beyond, in discussing sustainable and non-sustainable business practices in the Baltic countries. This was an initiative of the SSE Riga CSB, working in close cooperation with Tartu University, Tallinn University of Technology (Estonia), ISM Business School (Lithuania) and Ventspils University College (Latvia). The first conference was hosted by Ventspils University College in 2013 with more than 60 participants from the Baltic states, Scandinavian countries, the UK, Turkey, Germany, Finland, Russia and Belarus. The 5<sup>th</sup> conference: Entrepreneurship, Innovation and Regional Development – EIRD 2017 was held in June 2017 at Ventspils University College, Ventspils, Latvia. The 4th EIRD was held at the Tallinn School of Economics and Business Administration, Tallinn, Estonia in June 2016, while the 3<sup>rd</sup> EIRD took place at ISM in Vilnius, Lithuania in September 2015, yet the second conference was hosted by Tartu University in September, 2014. Arnis Sauka was one of the initiators of these conferences.

Professor Arnis Sauka (Head of the Centre for Sustainable Business at SSE Riga), Professor Ute Stephan (King’s College London, U.K.), Professor Alfredo de Massis (Director of the Centre for Family Business Management, Free University of Bolzano), Christine Hebert (Co-founder and CEO, Blue Lobster) and Benedetta Spattini (Cofounder, WHATaECO) participated in the panel discussion, moderated by Lejla Abbasova.

### ***SSE Riga Shadow Economy Index for the Baltic Countries and Conference on the Shadow Economy***

Study developed by Talis Puntins and Arnis Sauka. The aim of the SSE Riga Shadow Economy Index for the Baltic Countries is to measure the size of the shadow economies in Latvia, Lithuania and Estonia as well as to explore the main factors that influence participation in the shadow economy. SEB generously supported the Index during the period of 2012-2016. The SSE Riga Shadow Economy Index for the Baltic Countries has been presented annually since 2010 at a mid-May conference organized by SSE Riga (Arnis Sauka, Dana Kumpina) in cooperation with the Latvian Chamber of Commerce and Industry and the Ministry of Finance of Latvia. Recent conference was held in 2022 for the 12th time. The media reports on the Index extensively throughout the year. The conference attracts major interest from policymakers, the Index is used extensively by the Ministry of Finance of Latvia, the Ministry of Economics of Latvia, the Estonian Tax and Customs Board, and various associations and NGOs in the Baltic countries. <https://www.sseriga.edu/shadow-economy-index-baltic-countries>

The methodology of Talis Putnins and Arnis Sauka (2015) has been applied by the authors to measure the size and determinants of the shadow economy also in other countries. ### ***The Shadow Economy in the Construction Industry in Latvia***

The SSE Riga CSB, in cooperation with the NGO BASE (Business against the Shadow Economy) and the Partnership of Latvian Construction Entrepreneurs, has launched a study on the size and determinants of the shadow economy in the construction industry. Author of the study is Arnis Sauka. The study involves a quantitative survey and an expert interview to analyze key challenges and provide policy suggestions to reduce the shadow economy and increase the competitiveness of the construction industry in Latvia. Most recent conference was held in 2020 with several ministers and representatives of major NGOs as well as the main construction industries attended the conference. ### ***FICIL Sentiment Index and conferences on the foreign direct investment climate in Latvia***

The FICIL Sentiment Index was established in 2015 by the Foreign Investors' Council in Latvia (FICIL), developed by Arnis Sauka. The key aim of the Index is to foster more evidence-based policy decisions to further promote a favourable investment climate in Latvia. We aim to achieve this by summarising the key concerns and suggestions of the main foreign investors in Latvia – representatives of companies that have made the decision to invest in the country and have been operating here for a considerable time period. The FICIL Sentiment Index draws on a survey – mini case studies of foreign investors in Latvia. Findings are annually presented by Arnis Sauka at the FICIL Sentiment Index conference organised in cooperation with FICIL. The conferences were attended by key policymakers in Latvia, including ministers, officials, ambassadors, and foreign direct investors. ### ***Forum: Fight Against Smuggling***

On 30 June 2022, SSE Riga hosted the 4th national forum on smuggling-related problems, “Fight Against Smuggling: Challenges and Progress”, organised by the association BASE (“Business Against Shadow Economy”) in cooperation with SSE Riga and the research centre SKDS. During the forum, research data were presented, which reveal the opinion of the general public on the smuggling problem in the country, as well as the attitude towards the purchase of smuggled goods, knowledge about places to buy smuggled goods, as well as possible penalties and actions to reduce smuggling. ### ***World Economic Forum Global Competitiveness Index***

WEF Global Competitiveness Index focuses on analysing factors that contribute to the productivity of the economy, taking into account the latest trends in the specificity of competitiveness that comes with globalisation and new digital technologies. In Latvia the research “Global Competitiveness Index” is represented by the Centre for Sustainable Business at SSE Riga (led by Arnis Sauka).

### ***Pensi-Meter***

Arnis Sauka, in cooperation with SEB bank, has carried out research to determine the awareness of Latvians, Lithuanians and Estonians about the pension system and how they are preparing for retirement. The ‘Pensi-Meter’ research discloses that the readiness of residents of the Baltic states for retirement, in aggregate, can be assessed as low. Employees in Latvia are the least ready for retirement compared to residents of the other Baltic states. This is the first research of its kind; residents of the Baltic states provided their opinion in in-depth interviews, characterising the level of readiness of the population for old age and receiving a pension in the future. The Pensi-Meter was first launched in 2015 and presented by Arnis Sauka at a press conference. SEB also repeated the study in 2016. The study attracted substantial media coverage in all three Baltic countries.

### ***Experts on exports***

In 2014 and 2015, Experience Exchange seminar “Exporting Experts” was launched by Arnis Sauka in cooperation with the Latvian Chamber of Commerce and Industry. Considering the role of internationalization in small economy such as Latvia, the focus of seminars in 2014 and 2015 was on exploring quantity and quality of export practices by Latvian companies.
